C24/201 PARISH MATTERS

Councillor Callear attended a meeting with Councillor Jhawar, the Clerk, and Andrew Careless from Telford and Wrekin Council. They met at the bridge at the bottom of Millenium Village following reports of the ground being unsafe and unpassable. Andrew Careless is going to quote for the pathway to be cleared, and for some compact stones to be laid. Councillor Millward Thomas advised that there are drainage works currently being completed in the same area which could be a contributing factor to the ground being so wet. Once the quote has been received, Borough Councillor Sahota could allocate some of her Pride Funding towards this

project, and Councillors can discuss the option of match funding.

Councillor Callear advised that Andrew Careless met with the Clerk at the pathway at Red Lees and will quote to have the pathway resurfaced. Once the quote has been received, Councillors

Due to the quote by Granville Construction & Maintenance coming in at £4,188.00 for the antigraffiti treatment, it was proposed by Councillors that the Clerk discuss the treatment with Safer Stronger to see if they can quote and/or match fund. Even with splitting the cost with Hadley Parish Council, £2,094 per Council is a large sum of money. The cost of the mural being painted only cost £2,163.50 which was split between both Councils so Councillors would not be willing to spend that amount on an anti-graffiti treatment.
