AC25/007 PUBLIC SESSION

Students from Meadows Primary School who make up the school's student council joined the Annual General Meeting of Ketley Parish Council this evening to ask some of the questions that

had been put together by the students

Student: as students at Meadows Primary School, we have noted poor parking, speeding, and road rage by road users around our school. What is being done to try and make this safer for us? **Councillor Sam Millward Thomas:** parking and speeding by Meadows Primary School has been an issue for a long time unfortunately. The Parish Council aims to work with the school directly, parents of students, and the students themselves to try our best to make it safer. The Parish Council also work alongside Telford and Wrekin Council to promote road safety.

Councillor Eileen Callear: the safety issues around parking and speeding are quite difficult for the Parish Council to address. We would encourage people to walk where they can, to minimise the amount of traffic. As students at the school, who are affected directly, you can work to educate your parents/guardians.

Councillor Sam Millward Thomas: students have already done amazing work regarding road safety, and the posters that they have created by them are already posted in and around the school grounds.

Councillor Helen Barker: it would be a good idea for the Parish Council and/or the school to discuss the issues we are facing with other schools within Telford to see what steps they have taken to help with parking and/or speeding issues at their schools and see if they suggest anything that we can implement.

It was proposed by the Chair that we break standing orders (public session to last only 15 minutes) on this occasion to allow for all the students in attendance to present the questions that they had ready to be discussed at the meeting this evening.

Student: we have experienced anti-social behaviour, and witnessed teenagers swearing, littering, and loitering in groups in and around the parks and open spaces in Ketley. What can be done to make us feel safer?

Councillor Sam Millward Thomas: as a Parish Council, we have worked with the relevant agencies and had CCTV installed in some of the open spaces in Ketley, including the parks. We have increased our work with the police and the Neighbourhood Enforcement Officers (NEO's). Ketley Parish Council have also started a youth club on Thursdays during term time to create a safe environment for children to come and do nice things with their friends. As a Parish Council, we can look at the installation of more lighting in the parks to help deter anti-social behaviour. **Councillor Eileen Callear:** is there anything, as students, you feel we can do as a Parish Council to help with this?

The students will go away and ask their classmates the question raised by Councillor Eileen Callear and return at a later date with some suggestions for the Parish Council to consider.

Student: we have noticed that sometimes the bins are not being emptied, how can we make sure they aren't left to overflow?

Councillor Sam Millward Thomas: we have two staff members who make up the Community Action Team (CAT), and they can help us as a community by emptying overflowing bins if they have been left. If you do spot an overflowing bin, or any bins that need emptying, let your Parish Councillors know.

Councillor Helen Barker: did you know there is an app called My Telford? If you ask your grown up(s) to download the app to their phone, when you are out and about in the Parish, if you see anything that you would like to report, including overflowing bins, you can do this instantly via the app. It will also pick up your location at the time of reporting so the relevant people can find the issue and fix it as soon as they can.

Councillor Eileen Callear: as students, you could make some posters about littering and why it is bad for the Parish and have them put up in and around school. I will also look at getting you some more litter pickers.

Student: we have noticed that there are more homeless people in Telford, and we want to help. What can the Parish Council do to help us to help them?

Councillor Sam Millward Thomas: everyone should be able to access the support they require, especially when it comes to housing and homelessness. Telford and Wrekin Council have a homelessness strategy which you can find out more about on the Telford and Wrekin Council website.

Councillor Eileen Callear: you can report any concerns for individuals who you think may require housing support on the Telford and Wrekin website. Telford and Wrekin Council also work with charities such as Stay, KiP, and multiple other housing associations in the aim to eradicate homelessness.

Student: by Mannerly Wood Play Area, there is an uneven pathway which is a health and safety hazard for anyone walking, can you help us get this fixed?

Councillor Sam Millward Thomas: this is definitely a concern, and is something that we can we, as a Parish Council, can work with Telford and Wrekin Council on to find a solution.

Councillor Eileen Callear: as mentioned before when we discussed the reporting of overflowing bins, an uneven/unsafe pathway can also be reported via the My Telford app.

Councillor Helen Barker: reporting anything of concern to the Parish Council is amazing, as it gives us the information to try and push for solutions. However, the more reports that are logged via My Telford regarding the same issue will highlight it to be rectified sooner.

Councillor Amrik Jhawar: it is part of our duty, as Councillors, to complete regular ward walks and report any issues that we may come across to the relevant agencies. As Councillors, we have stronger knowledge of the different teams within Telford and Wrekin Council in which to direct the reports to.

AC25/016 PARISH MATTERS

Councillor Hilda Rhodes advised that a car had crashed into the garden of 70 Copper Beech Road on Monday 12 May 2025 and wondered if the police had provided the office with any further information regarding this incident

The Clerk will follow up with the police to obtain any relevant updates on this matter Councillor Eileen Callear provided Councillors with an update regarding the right of way that connects Ketley, Oakengates, and Hadley & Leegomery at the bottom of Millenium Village – the road is being resurfaced by Persimmon Homes (developer at Hadley Gate) who have allocated full funding for this work to be completed. Works are due to commence over the next few months Councillor Eileen Callear advised that environmental agencies are currently conducting investigating pollution at Ketley Brook, any updates will be shared as and when they are received The Clerk was emailed by a resident concerning a tree to the front of their property that is being targeted by vandals. Councillor Eileen Callear has been in touch with this resident and explained to them that the responsibility of protecting the tree lies with Wrekin Housing Trust, but the vandalism can be reported to the police as it falls under anti-social behaviour

Councillor Amrik Jhawar is still receiving resident complaints from those who live on Broadway regarding the weekend parking issues

The Clerk will follow up with Telford and Wrekin Council regarding the TRO that was presented to Council in October 2024

Councillor Helen Barker reported a vandalised Virgin Media cabinet to Virgin direct who have come and taped it off ahead of it being rectified fully.

Councillor Barker also advised that the individual who consistently rides his quad bike illegally has been reported to her by a resident, who is now keeping a log of all sightings and timings in order to pass over to the Police in the hopes of catching them

The Clerk has already discussed this with Councillor Helen Barker, and has advised the police of this

Councillor Helen Barker has been asked to raise a resident question on behalf of Councillor Nick Heath in his absence from this evening's meeting – the pathway to the rear of the Community Centre, known as Coronation Walk, has still not been rectified

The Clerk will ask for Severn Trent to come out to the site again to see what assistance they can provide. The Clerk will also continue to chase Andrew Careless as she has not yet received any correspondence from him off the back of her previous email/call attempts Both Councillor Dave Elliott and Councillor Maggie Evans have received amazing feedback from residents who attended our VE Day Tea Party on Saturday 03 May 2025, as well as being asked to pass on thanks to all staff and Councillors involved who made it happen and could attend

Councillor Eileen Callear currently sits on the Community Governance Committee, however, advised that she will be resigning her seat on this committee prior to the next meeting Councillor Sam Millward Thomas was happy to see that there were not too many changes to Ketley Parish, but suggested that we send a letter to the residents who live on Beveley Road and Lea Brook to obtain some feedback as to how they feel due to it being them who will be affected directly by the proposed plan

Councillor Helen Barker spoke about 'community cohesion', but the proposed plan to make the already smaller Parish of Ketley smaller doesn't make sense. If Ketley was to stay as is currently, but take on Overdale, Ketley would stand at approximately 400 residents per Councillor. By doing this, Lawley would have approximately 500 residents per Councillor in comparison to their current standing of approximately 1,000 residents per Councillor. Councillor Barker also advised that in the proposal, St Georges and Donnington have been noted as 'sharing a common identity of being older established communities in the borough with similar needs, demographics and identity'. She feels Ketley and Overdale share more commonalities and history in comparison to St Georges and Donnington, so it would make more sense for Overdale to merge into Ketley Parish Council

Councillor Eileen Callear raised the question of what can we do, as a Parish Council, to get people involved

Councillor Millward Thomas suggested that we hold a public consultation where the residents are invited in to have their say and ask any questions they may have, to gain a deeper understanding of the Governance Review, and how it directly affects them

Councillor Maggie Evans proposed that we advertise the history of Ketley as part of this consultation so that residents can gain a deeper knowledge of the links between Ketley and Overdale

Councillor Millward Thomas suggested that we establish a suitable location in which a bench can be instituted, and then we can respond to the family with that location as the only appropriate offer
